BOARD MEETING MINUTES 02/15/21

Board Meeting Minutes 02/15/21

- 1. Welcome attendees Holly, Glen, Angela, Jerri, Steve, Michele, Todd, Kealy, Cathy. Meeting called to order at 7:03 PM Guest, Joanna Toepfer.
- 2. Swearing in of new board members Joanna declared that our new officers assume their duties as of January 1, 2021.
- 3. Secretary Report Jerri submitted Minutes of November 12, meeting as transcribed from audio file.
- 4. Show Update Joanna and Jerri
 - a. Facility Stranahan will not be available this year, actively seeking new site. Anyone with suggestions should send to Joanna or Jerri. Needs at least 12,000 sf
 - b. Dates Date can be changed but need to research competing shows for alternate dates. Looking for venue loyalty so we can count on future access.
 - c. Budget cannot work on budget until we have a site.

5. Treasurer – Glen

- a. Report Account status update provided. CD will mature 2/22/2021 at which time balance will be transferred to savings. 2020 P&L provided. Jerri made a motion to accept the Treasurer's report, Michelle seconded. Motion carried.
- b. Budget- proposed budget reviewed line by line. Jerri made a motion to accept proposed budget, Angela seconded. Motion carried.
- c. Purchase of a computer tablet that can be used by moderators to accept payment for classes, sessions, etc. via the square. It seems to be an up-and-coming trend that could help. Glen made a motion, Michelle seconded to allocate \$300 for purchase of a compatible android device. Motion carried.
 - i. May need training, or perhaps a typed-out instruction sheet, laminated?
 - ii. Also, would internet be required for this? Internet can be accessed by cell phone hotspot, or transactions can be run offline, and put through weekly as needed by someone with a hotspot.
- d. Keeping small bills on hand at the craft center for change, discussed and approved.
- e. Badges for officers, others. Do we want to continue this? People used to pay for their own. Suggested that we drop the year on the badge and follow a policy that individuals only wear an officer badge while holding office. Suggest we take orders for badges to be paid by the individual. Michelle will collect this.

6. Craft Center

- a. Discuss the current craft center policy of a minimum of two working in the craft center. After discussion about pros and cons, Steve made motion to amend the policy to allow moderators to work alone, while waiting for participants to come as long as they carried a cell phone on their person for emergencies. Angela seconded. Motion carried. Also discussed fees due from moderators. Steve made a motion that moderators not be charged fees while actively teaching, but pay 50% fees when working on own projects. Michelle seconded. Motion carried. Note made to send class schedule out by email each Sunday, and post on Facebook. Holly and Kealy agreed to this.
- b. Concrete plan to complete plumbing, electrical work, and roof vents for craft center. Michelle and Steve will prepare an accurate list of what still needs done in electrical to allow Holly to discuss with Landlord. Angela will bring in a friend of her father to identify exact plumbing needs and possibly provide quote. Using that list Joanna will attempt to get additional quotes. Roof vents are up to Skip, discussed combining vents on common wall between metal and gem crafters to tie into one vent. Need to discuss rest with Skip.

- c. Minors using lapidary equipment. Propose we allow it with training and supervision. Not young children but maybe Jr. High & High School. Motion by Steve, second by Angela to table till next meeting. Motion carried.
- d. Selling the Frantom Cabbing machine. All agreed to post for sale.
- e. Snow Removal Lease will be reviewed to see if it is landlord or tenant responsibility.
- 7. Website Tonya wants to step down, will train a successor. Angela and Steve agreed to be trained via a Zoom meeting. We use WordPress and need to finish setup of Stripe account.
 - a. Getting classes and sessions on FB. Classes and sessions are currently listed.
 - b. Rocky Reader Link being added to FB as many people may not see it since it is hitting their junk mail now.
 - c. Rocky Reader website: need work sessions on calendar, new member form (only a renewal form is on the web), online payment system for memberships. Discussed using Square invoicing to help with this. Holly will train Michelle and give her access to square to send out invoices to prospective members.
- 8. Sunshine Cathy volunteered to call Linda McConnahay to see if she was interested in the position.
- 9. Fieldtrips Kealy is Field trip Chair. Since fieldtrips are not possible during Covid, she posts suggested museums and site on Facebook. Anyone with suggested trips and resources should contact her.
- 10. Status of groups Beaders not active, Extreme Beaders not active, Facetors no moderator, GC currently holding classes, MC currently holding classes.
- 11. Membership drives probably concurrent with activities, etc. but need to get things buzzing in the craft center in a COVID-19 safe way. Suggested possible Open House at clubhouse in June.
- 12. Open house. Possible Open House at Clubhouse in June and November. Steve and Michelle will work on this. Covid status dependent.
- 13. Monthly speakers Send suggestions to Kealy. Also, DVD programs available through MWF.
- 14. Can we get facetors and beaders? Need moderators.
- 15. What is the plan for the group auctions that should be going on? Can we do something on FB like a FB Live or some type of silent online bid? We need to get things going again and raise funds. Bring suggestions to next meeting or pass on to Holly.
- 16. Joanna donated gems to be given away at a meeting. Still need to be photographed and posted on Facebook for give aways at monthly meetings.
- 17. Meeting minutes. We need to have a way to get timely meeting minutes on record. Michelle suggested that we print as part of Rocky Reader issues as we used to. Good methods of maintaining a public record of club business.
