THIRD. The purpose or purposes for which said corporation is formed are:

A.-- To promote and stimulate popular interest and education in the study of geology mineralogy, paleontology, lapidary and other related subjects and through membership in the corporation to sponsor and provide means of co-ordinating the work and efforts. of all persons or groups interested therein.
